05/08/26 13:33 MET WITH [REDACTED] WHO SHOWED ME THE BALCONY. BALCONY IS ALMOST FULLY SURROUNDED MINUS 2 SIDES. [REDACTED] STATED HE WAS GOING TO PUT UP BLINDS TO BLOCK OUT THE SUN AND WEATHER. I STATED THAT WOULD BE SUFFICIENT. BOTH DOGS HAD BOG BEDS, WATER, AND FOOD ACCESSIBLE TO THEM. RO STATED DOGS ARE BROUGHT IN OFTEN. NO WELFARE CONCERNS AT THIS TIME. CL42

05/13/26 16:18 SPOKE WITH RP [REDACTED] RE COMPLIANT. INFORMED RP THAT SFACC HAS BEEN OUT AND SPOKEN WITH THE DOGS OWNER. OFFICERS WERE ALLOWED INSIDE HOME TO INSPECT OUTSIDE AREA REPORTED IN THE COMPLAINT. RP STATED THAT DOGS HAVE BEEN BARKING SINCE 0800 THIS MORNING AND GOES ON ALL DAY/ EVERYDAY. I TRIED TO EXPLAIN NOISE COMPLAINT VS WELFARE ISSUES. RP STATED THAT THEY HAVE FILED NUMEROUS 311 COMPLAINTS. SFPD HAS ATTEMPTED TO CITE RO BUT RO DOES NOT OPEN THE DOOR. RP INSISTENT THAT BALCONY IS COVERED IN URINE AND FECES. RP WAS INFORMED THAT OFFICER WENT OUT 5 DAYS AGO. RO ALLOWED OFFICER INSIDE UNIT AND ON BALCONY. NO FECES , BOTH DOGS HAD WATER AND BEDS. RP WAS INSISTENT THAT AN OFFICER DID NOT GO IN AND THAT FECES WAS STILL COVERING BALCONY. I CONFIRMED WITH CL42 WHO WAS AT THE DESK NEXT TO ME. SHE DID INDEED GO INSIDE AND ON THE BALCONY. I ASKED RO TO RECORD THE THE BALCONY NOW AS I WOULD LIKE TO SEE WHAT HE IS SEEING. HE STATED HE HAS BEEN AT WORK ALL DAY AND THAT HIS UNIT DOES NOT HAVE A VIEW OF THE BALCONY OR THE DOGS. HE CAN ONLY HEAR BARKING. RP BECAME FRUSTRATED STATING SFACC IS NOT DOING ANYTHING AND HE PLANS TO BRING MEDIA ATTENTION. I REITERATED THAT AS BARKING CAN BE A NUISANCE IT IS NOT ILLEGAL TO LEAVE DOGS OUTSIDE AND THAT RO WAS IN COMPLAINT WITH ALL ENFORCEABLE LAWS. HE STATED THAT RO DOES NOT HAVE PROPER SHELTER. I EXPRESS THAT RO INFORMED OFFICER THAT DOOR IS LEFT OPEN DOING THE DAY SO DOGS CAN COME AND GO SO WOULD NOT NEED A DOG HOUSE. RP STATED THAT WAS NOT TRUE DOOR IS NOT OPEN. I WAS ABLE TO CONFIRM WITH THE VIDEO IN ACC DISPATCH THAT THE DOOR IS INDEED LEFT OPEN, DOGS CAN COME AND GO. I ASKED RP TO SEND VIDEO IF DOGS ARE LOCKED OUTSIDE WITH NO ACCESS TO INSIDE AND WE CAN ADDRESS THE SHELTER ISSUE. BALCONY IS COVER ON TOP WITH PLYWOOD WOOD TWO SIDES. I DID REITERATE THAT EVEN IF THE DOGS HAD A DOG HOUSE IT WOULD NOT STOP THE BARKING ISSUE. RP WAS EXTREMELY FRUSTRATED, BUT I TRIED TO EXPLAIN THAT SFACC CAN ONLY WHEN RO IS IN VIOLATION OF STATE OR LOCAL LAWS. AT THIS TIME NO VIOLATIONS HAVE BEEN FOUND. COMPLAINT CLOSED. INFORMED RP TO REOPEN INVESTIGATION IF ANY WELFARE CONCERNS ARISE IN THE FUTURE. SFACC WOULD BE HAPPY TO ADDRESS THEM. AS OF NOW THIS SEEMS TO BE A NOISE COMPLAINT. SR33
