11/03/24 09:19 RE; A24-346570 I RAN INTO THE SAME ROOMMATE AS LAST TIME WHO INFORMED ME THAT THE DOGS WERE BACK, THAT THE RO HAD MOVED OUT BRIEFLY BUT WAS BACK. THE RO WAS NOT HOME AT THE TIME BUT I WAS TOLD HE WOULD BE BACK SOON. I ELECTED TO WAIT FOR HIM. WHILE STANDING BY A NEIGHBOR APPROACHED ME ABOUT THE DOGS, HE SEEMED MOSTLY ANNOYED BY THE BARKING AND SECONDARILLY CONCERNED ABOUT WELFARE. THE RO ARRIVED AND READILY ALLOWED ME TO ENTER AND MEET THE DOGS. THEY ARE BOTH IN GOOD BODY CONDITION AND QUITE FRIENDLY. THE RO RENTS A SINGLE ROOM IN THE UNIT AND USES THE DECK SPACE TO MANAGE THE DOGS WHEN HE IS NOT HOME. THE DECK WAS CLEAR OF FECES AND HAD FOOD AND WATER. EACH DOG HAS A BED AND THERE WAS EVEN A COUPLE TOYS FOR THEM. I TOLD THE RO THAT THEY CAN NOT BE LEFT OUTSIDE OVERNIGHT WITHOUT PROPER SHELTER, HE STATED THAT HE DOES BRING THEM INSIDE AT NIGHT, THO SOMETIMES ITS LATER IN THE NIGHT. THE WAY THE DECKS ARE STACKED , THERE IS SOME PROTECTION FROM THE ELEMENTS. THE CONDITIONS ARE ADEQUATE, THIS SEEMS LIKE A BARKING COMPLAINT. SHOULD FURTHER RP'S CALL IT SHOULD BE TREATED AS SUCH, UNLESS EVIDENCE OF WORSENING CONDITIONS ARE PROVIDED. RO STATED HE INTENDS TO MOVE TO THE EAST BAY SOON. I ADVISED HIM , SHOULD HE STAY IN SF HE IS REQUIRED TO LICENSE BOTH DOGS. MC35

11/19/24 20:07 RECEIVED A CALL FROM AN RP COMPLAINING ABOUT THE BARKING. HE DID DISCLOSE THAT HE WAS MOSTLY UPSET ABOUT BARKING. HE DID SAY THAT THE DOGS DO NOT HAVE SHELTER OR WATER AT ALL TIMES. HE SAID HE WOULD SEND PHOTOS. I TOLD HIM I WOULD LOOK INTO THE SYSTEM AND CHECK WHAT WE HAVE. DUE TO THE ABOVE MEMO I WILL NOT PLACE IN A CALL IF THE PHOTOS SHOW DECLINING CONDITIONS WE CAN RESPOND ACCORDINGLY. -MT37

DURING THIS TIME A NEIGHBOR WALKED BY SAYING THE DOGS HAVE NOT BEEN HEARD IN A WEEK AND THINKS THEY MOVED OUT. I ATTEMPTED TO CONTACT 1459A WHO INFORMED ME THEY DIDNT HAVE A DOG. I THEN WALKED UP TO 1459 AND WAS MET BY A COUSIN OF MAIN RESIDENT OF UNIT. I WAS TOLD NO ONE ELSE IS THERE AND THERE ARE NO DOGS. I ASKED ABOUT A BACK PATIO AND COUSIN DID NOT KNOW IF THERE WAS ONE AND INVITED ME IN TO CHECK. I SAW BOTH ROOMS THAT WERE FULLY FURNISHED AND WALKED TO BACK OF UNIT. THERE WAS A DOOR AT BACK OF UNIT AND I OPENED TO SEE NO DOGS BUT EVIDENCE OF DOGS (FAKE GRASS PATCH W FECES, BOWL HOLDERS, SMELL OF URINE/FECES. IN THE KITCHEN WERE 2 DOG BEDS. COUSIN GAVE ME THE NUMBER TO RESIDENT. I CALLED AND LEFT VM ASKING FOR A CALLBACK TO CLARIFY IF RO STILL LIVES THERE OR NOT. CO40
